Rogue Landlord Tracker

The latest fines and top stories

Total fines surge by £20k since October

The Mayor of London's office opened access to the Rogue Landlord and Agent Database, allowing individuals to search for enforcement action in the capital.

We track and aggregate this dataset to discover enforcement trends. The highlights are shown below, with a focus on the rising total number of fines levied against poor practice

As councils catch up on reporting in the wake of unprecedented enforcement, total fines have hit the £9.87 million mark this month, increasing by £20,250 since we last reported in October.

Total enforcement in London is now under £130k away from hitting the £10 million milestone.

October's Top Rogue Landlord Stories

Thanet Council Fines Four Landlords over £60,000 in Three Days for Non-Compliance

Thanet Council imposed four fines totalling over £60,000, with one company being fined £40,000 for non-compliance and another £5,000 for disregarding HMO rules.

A director was personally fined £20,000, highlighting the council's commitment to enforcing housing standards.

Norfolk Landlord fined £30,000 for Illegal HMO housing 17 Residents

A landlord in Norfolk was found guilty of operating an unlicensed HMO with 17 occupants in a four-bedroom terraced property.

The landlord was served a £30,000 fine, emphasising Broadland councils' commitment to keeping the private rental sector safe

Hackney Landlord fined £16,000 due to Incorrect HMO Licensing

A landlord in Hackney was fined £15,900 due to a missing HMO licence.

The offender claimed ignorance of Hackney's licensing schemes, asserting no knowledge from local publicity, internet forums, or council notifications.


