A word from Orla

2023 has been another landmark year for licensing and enforcement. A record breaking **32** new schemes were launched last year, a figure that hits nearly **50** when considering active consultations.

The beginning of 2023 saw a commitment from the government for increased enforcement and a crackdown on rogue landlords - our data shows that this has certainly been delivered. With the total fines of the year hitting an unprecedented **£9.87 million** in 2023, 2024 will see fines reach over the £10m mark. (see page 7).

The state of enforcement in London is unlike anything we've seen in the past, with over **87%** of London boroughs with an active scheme or consultation in place (see page 5). With so many more schemes for London in the wood-works, it will be more important than ever this year for landlords and agent to keep a keen eye on increasing regulations.

In the face of growing enforcement, 2023 has been an exciting year for Kamma as we formed new partnerships with leading estate agents such as JLL, Knight Frank and Foxtons, and integrated our services with Goodlord's CRM. We also saw a **74%** increase in licensing guidance offered from 2022 (see page 9). As always, we are very proud to be working with market leaders that help us revolutionise compliance in the lettings industry.

2024 already promises plenty of new schemes around the corner, (see page 4) and if 2023 is anything to go by, this year will be another landslide year for fines and enforcement. Landlords and agents will have to be more diligent than ever in 2024, and Kamma is here to help.



Record breaking fines for 2023

Total fines for rogue landlords and letting agents has crossed the £9.8 million mark

Kamma has recently reported that total fines for rogue landlords and letting agents has crossed the £9.8 million mark for the first time. This represents a total increase of over £1.5 million from the beginning of 2023.



Kamma is the only company to track the Mayor of London's Rogue Landlord and Agent Checker in order to deliver analysis of enforcement trends across the capital. In just the past year, the total fines for letting agents and landlords have increased by £1,567,509 - from £8,304,946 in January to £9,872,455 in December 2023.

Fines saw a record breaking 19% increase from January to December in 2023. This is a higher rate than the 13% increase from January to December in 2022 - upcoming regulation changes and increased enforcement will likely only make fines grow at an even faster rate in 2024.

With plenty of fines in the backlog waiting to reported, we'll likely see total fines hit the £10 million mark within the first few months of 2024 as new schemes and regulations are being introduced at an unprecedented rate if the looming £10 million figure indicates anything, it's that having licensing regulations in order for HMO's is more important than ever for 2024..


