# A word from Orla

Earlier this year we predicted that 2024 was set to outpace 2023's tally of 32 new schemes. This increase in licensing measures hasn't let up, with a **30% rise** in new schemes for 2024 far compared to this time last year (see page 3).

As more schemes are introduced, their complexity continues to evolve. **One third** of selective licensing schemes implemented in the past year have been **targeted on street level** (see page 3). This granularity indicates a more targeted approach to enforcement, highlighting the need for landlords and agents to be increasingly vigilant and informed about the specific requirements and implications for their properties.

Furthermore, the enforcement landscape in London has seen substantial developments, with fines exceeding £10 million (see page 7), according to Kamma's rogue landlord tracker based on the Mayor of London's database. This increase in enforcement activity across the capital, along with successful measures such as the 76 prosecutions in Redbridge from their last selective scheme (see page 8), illustrates a clear trend towards more stringent enforcement and the significant consequences for non-compliance.

As we look ahead, the landscape for 2024 continues to evolve, with the promise of more new schemes (see page 5) and the likelihood of further enforcement action. For landlords and agents, this environment underscores the critical importance of staying informed and proactive in managing compliance obligations.

## Licensing in numbers: 2024 so far

2024 has over **30%** more licensing measures in place so far compared to this time last year. This means that 2024 is well on track to beat 2023's record of 32 new schemes. We've also seen that **58%** of the schemes launched in the past 12 months have been selective. **One third** of these schemes have targeted properties on a street level.





# Total fines for rogue landlords exceed £10m

Our analysis of the rogue landlord database for London reveals total fines for the capital of:

Kamma is the only company to track the Mayor of London's Rogue Landlord and Agent Checker in order to deliver analysis of enforcement trends across the capital. Since the start of 2024, fines for London have increased by £377,213

Fines saw a record breaking 19% increase from January to December last year. This is a higher rate than the 13% increase from January to December in 2022 - upcoming regulation changes and increased enforcement will likely only make fines grow at an even faster rate in 2024.

With plenty of fines in the backlog waiting to reported, we'll likely see total fines further exceed this £10 million mark as new schemes and regulations are being introduced at an unprecedented rate - if this £10m figure indicates anything, it's that having licensing regulations in order for HMO's is more important than ever for 2024..




